Arrêté royal du 6 décembre 2005 –capitaux dus au Fonds des accidents du travail en application de l'article 4 de l'arrêté royal du 13 janvier 1983 portant exécution de l'article 42bis de la loi du 10 avril 1971 sur les accidents du travail pour les accidents survenus à partir du 1^{er} janvier 2003 –nouveaux barèmes

L'article 1^{er} de l'arrêté précité introduit, pour les accidents survenus à partir du 1^{er} janvier 2003, de nouveaux barèmes, dont copie en annexe, à utiliser pour le calcul des capitaux à verser au Fonds des accidents du travail dans le cadre du cumul avec les pensions.

L'article 2 de l'arrêté prévoit que les nouvelles dispositions s'appliquent aux capitaux dus au Fonds à partir de la date d'entrée en vigueur dudit arrêté.

L'arrêté a été publié au Moniteur belge du 15 décembre 2005.

Il entre donc en vigueur le 25 décembre 2005, soit 10 jours après sa publication (article 6 de la loi du 31 mai 1961). Il s'applique aux capitaux dus au Fonds à partir de cette date.

Deux situations peuvent se présenter :

- les cas visés à l'article 4, alinéa 4, de l'arrêté royal du 13 janvier 1983 pour lesquels la date de prise de cours de la pension se situe avant la date de règlement de l'accident (date de l'entérinement de l'accord ou la date à laquelle la décision judiciaire est coulée en force de chose jugée) ;
- les cas visés à l'article 4, alinéa 5, de l'arrêté royal du 13 janvier 1983 pour lesquels la date de prise de cours de la pension se situe après la date de règlement de l'accident.

Dans les deux situations, deux conditions doivent être remplies pour que le capital soit dû au Fonds :

- le cas doit être réglé définitivement ;
- la victime ou son ayant droit en cas d'accident mortel doit être pensionnée.

Les nouveaux barèmes sont d'application aux accidents survenus à partir du 1^{er} janvier 2003 pour lesquels les deux conditions énoncées ci-avant sont rencontrées à partir du 25 décembre 2005.


Pour les révisions visées à l'article 4, alinéa 7, de l'arrêté royal du 13 janvier 1983, les nouveaux barèmes s'appliquent soit aux cas pour lesquels l'entérinement en révision est notifié à partir du 25 décembre 2005, soit aux cas pour lesquels la décision judiciaire (en révision) est coulée en force de chose jugée à partir du 25 décembre 2005.

Pour les remboursements des capitaux visés à l'article 4, alinéa 8, de l'arrêté royal du 13 janvier 1983 lorsque la victime ou l'ayant droit ne peut plus prétendre à une pension, il y a lieu d'utiliser les mêmes barèmes que ceux en vigueur au moment du calcul initial.

Les modalités antérieures concernant le versement des capitaux cumul pension restent inchangées.

Les régularisations éventuelles qui résulteraient de l'application tardive des nouvelles dispositions seront effectuées d'office par le Fonds.
